### **Stroud Office CQC Inspection**

Disappointingly, the CQC inspection report is not yet available. We look forward to sharing the findings with you on receipt from the Inspector.

### **Promising Developments in Treatment for Alzheimer's and Parkinson's**

Clinical trials are currently underway after it was noticed that people with Parkinson's and Alzheimer's diseases had impaired insulin signalling. When you have eaten a meal, your body releases gut hormones, called incretins, to signal to the pancreas that insulin needs to be released. It is this signalling which has been found not to be working properly.

Initial studies have shown that treatment with insulin and/or incretins had a positive effect on the plaques which form in the brain in Alzheimer's, causing the progressive symptoms of the disease. Existing plaques have been reduced, and cognitive impairment improved. In Parkinson's, the treatment has reversed the loss of motor function.

The treatment has been shown to be effective when given as a simple nasal spray, making it painless and easy to administer.

Sadly, the trials are at a very early stage, so it will be a few years before the treatment is readily available.

#### The Better Care Fund

The Better Care Fund has been developed by the Department of Health and the Department for Communities and Local Government, in partnership with the Local Government Association, the Association of Directors of Adult Social Services, and NHS England.

The purpose of the Better Care Fund – now upgraded to the Improved Better Care Fund, is to integrate health and social care, provide funding for the scheme which is not permitted to be used for any other purpose, and to ease the transfer from hospital to social care. The Fund is intended to provide a single budget for NHS and social care, so people leaving hospital can choose their care provider(s), within the budget they are allocated.

We have recently learned that local government representatives have withdrawn their support for the Fund, due to unacceptable last minute changes having been made. We think that the scheme will still go ahead, as there is a legal framework for the Fund in the amended NHS Act 2006 (section 223GA).

We will let you know when we hear of further developments.
